## Rules of Public Comment Brought Up Again at Council

The rules on how public comment is allowed to be conducted was once again addressed at the Town Council meeting on Monday night, April 10.

Resident Glenn Douglas, began the discus-

sion and spoke on a number of issues he felt needed to be addressed by the council.

He began by saying he was happy to see that the council has started to record their decisions through a role call vote, mentioning that the rule was established in the Town Charter. He added,

"This is the first time in 16-years that I've seen that," referring to the voting method.

Douglas also pointed out some confusion regarding the new rules for Public Comment, saying that he was told the rules were adopted in 2017, but after some **continued on page 7**

## Black Tells Board, "We're a Very Safe School District"

After having a moment of silence for victims of the latest school shooting during the beginning of the meeting, the School Board received an update regarding safety upgrades during the April 4 meeting.

"I think what we see internally is anytime another incident happens everyone gets worried," said Superintendent, Dan Black.

He said he wanted to

reiterate how safe the schools are in Londonderry.

"We're a very safe school district," said Black.

Black pointed to things like the emergency operations committee, which includes school resource officers as why he feels the district is safe. He also pointed to the second Alice drill taking place.

"We're in a really good place," said Black.

The district is currently in the process to make upgrades to the

district's safety infrastructure.

Business Administrator, Lisa McKenney, pointed out that they have three major funding sources right now for the upgrades, which includes a grant and two warrant articles that were approved.

"I thought it was a good time to update the School Board and the public about where we stand," said McKenney.

McKenney stated that the \$560,000 SAFE **continued on page 2**

## Young Road Project Hits a Snag at Planning Board

The Planning Board were scheduled to review a proposed subdivision plan during its April 5 board meeting, but far too many waivers got in the way of moving forward with that review.

The developers proposal is for 21 single-family homes at 20 and 22 Young Road. Variations of this plan have been discussed conceptually for a number of months by various town boards and commissions.

Initially the plan was to put well over double that amount of dwellings on the two properties.

The issue the Planning Board had to address during the meeting was in regards to the

waivers being requested by the owner of Cedar Crest Development, Aaron Orso.

"Before we get to the plan we have to determine if it's complete," said Planning Board Chair, Art Rugg.

Assistant Town Manager, Kellie Caron, said she had just received a waiver request for the 10 outstanding checklist items, and because she didn't have time to review it all, they were recommending that the application not be considered complete.

Caron pointed out that one of the items that was missing was the stormwater report. It was explained that a version of the report was submitted as part of the design review, however,

it wasn't part of the formal submission.

Planning Board member, Jake Butler, said it sounded like there was a conversation about everything by everyone involved, but "It's just not in the checklist itself."

Butler, who appeared to be speaking in favor of forgoing the oversight said, "It almost seems more of a housekeeping issue."

Another one of the waivers being requested **continued on page 3**

# State Approve Rolling Meadows Over \$4M for Water Supply

The Drinking Water and Groundwater Advisory Commission met on Monday of this week and announced that the Rolling Meadows Condo Association in Londonderry is scheduled to receive over \$4 million through PFAS Remedia-

tion Loan Fund and the Drinking Water State Revolving Loan Fund.

The funding will be for a drinking water connection to the Penichuck Water Works Company to rectify PFAS that have been discovered in the association's groundwater.

The funds the local condo association will

be receiving are largely targeted for construction costs, which are estimated at \$3.5 million with a \$350,000 added as a contingency. There is also roughly another \$215,000 in planning, engineering and legal costs.

The funds they will be receiving are from three different sources.

There will \$2 million from the Drinking Water and Groundwater Trust Fund (DWSRF) loan; \$1.5 million from a Polyfluoroalkyl Substances Remediation Loan Fund (PFAS RLF) Grant; and \$565,000 through a PFAS RLF Loan. The \$2M DWSRF loan will be forgiven, leaving the association to pick up the

remaining \$565,000.

The project is expected to start with the design by June 15 of this year with a construction start date of April 1, 2024. The anticipated completion of the project is expected to happen by June 15, 2025.

The project will benefit roughly 614 residents at Rolling Meadows.

In 2022, the Drinking Water State Revolving Loan Fund awarded a total of \$26,612,380 for Drinking Water Assistance Loans; Drinking Water Assistance Grants; New Hampshire Department of Environmental Services (NHDES) Programs; and Source Water Protection Grants.

# Historical Significance Questioned at Heritage Commission Meeting

The Heritage Commission reviewed a site plan amendment to merge two existing lots during their March 23 meeting. The proposal was to merge 215 and 217 Rockingham Road into one lot and the owner of V&W Investment Group, LLC

proposed to construct a 16 unit residential building.

Assistant Town Manager, Kellie Caron, said that the proposal was originally to be a mixed use site for commercial and residential when they went to the Planning Board last year for a conceptual discussion. However, it was decided to go

with just residential.

"It's since changed to the 16 two-bedroom unit residential only," Caron said.

One of the questions raised during the meeting came from David Ellis, who questioned whether or not there is any historical value to it.

He said he didn't know why the original

building was recognized as a historical resource by the state, which is a database kept by the state. Ellis said he didn't have access to the database to see why it was historic.

Caron said they can look into it, but didn't have any additional information.

"I don't have any

additional information," Caron said about the potential historical significance.

Vice Chair, Art Rugg, said by looking at it, he doesn't see anything historic about it.

"To me it doesn't look historic," Rugg said.

He also noted that it wasn't on the historic properties list for the town, which was developed from a 2006 task force.

However, Heritage Commission Chair, Christopher Kenney, said that it made sense to look into the historical significance first before moving forward.

"It doesn't look anything special to me either," Kenney said.

Aside from the question of whether or not there was any historical significance, Kenney noted they were missing information, including a lighting plan. The applicant wasn't in attendance to answer any question.

"This is missing a lot of stuff," Kenney said.

Caron said she didn't think it would be unreasonable for the applicant to come in if they have additional questions.

"I don't want to misrepresent what their intentions are," Caron said.

In terms of signage, Caron stated that she believed there wouldn't be any signage other than potentially a wall sign on the building.

"My understanding is there is no proposed signage," Caron said.

Overall, Kenney said that he thought the rendering presented looked good.

"The rendering looks decent to me," Kenney said.

The Commission ultimately decided to recommend that the applicant come back with material samples and with a design that had more color variation. Kenney said he also hopes to have someone in attendance to answer any questions they have.

Continued from page 1 grant mostly funded the access controls on all the different doors across the district.

"Which means you have to have a badge to get in," said McKenney.

McKenney noted that the latest article will allow them to complete the interior door locks at all of the schools. Particularly it will pay for the

door locks at the high school, middle school, and south school. She added that they would bid out for them and they would come back to the School Board to report out what the bids are when the information comes in.

She told the board they would also be bidding out for the access controls. Unlike the emergency alert buttons, McKenney said the

access controls can be done after school throughout the school year.

McKenney said they would also be getting interior door locks as well, which means if there is an emergency, the alert button will be triggered and the doors will automatically lock, taking away the human element.

She said they experience supply chain issues.

# Middle School Promotion Ceremony Set For June 14

One of the agenda items discussed during the March 21 School Board meeting was in regards to the promotional ceremony for Londonderry Middle School.

It was explained by Londonderry Middle School Principal, William Van Bennekum, that last year they decided they would "reignite" their 8th grade promotion ceremony.

"We're in place to do that," said Van Bennekum.

Van Bennekum said the ceremony will be taking place on Wednesday June 14 from 12 to 1:30 p.m. and will be taking place at the High School. He added that the high school students would be out by 11:30 a.m. when their exams end.

Following the ceremony, Van Bennekum said that families and those in attendance would have the chance to take photos.

For attire, he stated that they would be giving the students Londonderry High School t-shirts with the names of

all the students in the Class of 2027. He explained that it might be difficult to have formal attire since the students would be walking from the middle school to the high school.

"It will be casual attire," said Van Bennekum.

Van Bennekum said they will take a "ceremonial walk" where they become an official high schooler and will be greeted by their house assistant principal. He added that when they get to the high school they are split up into "houses" by alphabetical order.

"For the first time they'll be all together by

a house," said Van Bennekum.

Van Bennekum said they will be working with the high school for a guest speaker, possibly the senior class president or student council president.

From the middle school, Van Bennekum said they will have short speeches from some of the students and music selection by some students or by a student.

One question asked was whether or not there will be a limit on how many guests they could have per student.

It was pointed out by Londonderry High School Principal, Jason

Parent, that they can hold up to about 2,000 people.

"I think we'll be all set," Van Bennekum said.

Van Bennekum said it would also be the last day of school for eighth graders.

"They will finish on this day," Van Bennekum said.

Van Bennekum stated that there was a Committee of eighth grade teachers and himself that helped to organize the ceremony.

It was also noted during the meeting that in April there would be two Chaos & Kindness performances at the Middle

School Gym.

Van Bennekum explained that they would have two different performances, one for fifth and sixth graders and the other for seventh and eighth graders.

He said that the performers are good with the age groups.

"They are very good with this age group," Van Bennekum said.

He said the middle school PTO would be buying t-shirts to have raffled off. He added that each of the elementary school PTAS have donated to share in the costs of the fifth graders going to the middle school for the event.

was in regards to all the different lots having lot numbers identified by the assessor.

However, it was argued that they couldn't get those numbers without the merger going through first.

Caron stated that she has seen merger requests with formal submissions in the past, so they can identify the lot in advance.

She explained if they

were to accept any of the waivers, it would be for acceptance only.

"They still need to fulfill these requirements," said Caron.

Rugg said he thought it would be better to have all the information first before making a decision.

Butler asked if the board would consider at least accepting the waivers for completion of application purposes.

"Can't we as a board exercise some forward thinking here," said But-

ler.

The board took a vote to accept all the waivers for application completion purposes. That vote failed on a 2-5-1 vote, with Butler and Bruce Hallowell being the only members voting in favor.

Butler then asked if the board could get it on the agenda for next week.

Orso seemed to think they could have everything addressed in a week and could be back in front of the board.

"We feel very confident that we can be back here in a week with every one of these things addressed," Orso said.

However, there were concerns by some of the board members about how big of an agenda they already would have for the April 12 meeting and whether or not everything could be formally submitted in time.

The Planning Board agreed to continue the proposed subdivision plan at the May 10 meeting.

# Planning Board Gives Approval Subdivision Near LAFA

The Planning Board reviewed a proposed subdivision plan for 11 Sargent Road during its April 5 meeting. The development will put 13 homes abutting the LAFA Complex near the playground.

It was explained by George Chadwick, who

was representing the applicant, DHB Homes, that they have been discussing the plan for a while, noting they had a conceptual discussion with the Planning Board previously and have also met with the Conservation Commission and the Heritage Commission. He added that all the comments made were

added to the newest version of the plan.

It was explained by Chadwick that the subdivision would be on an approximately 18 acre property.

“What we are proposing is a 13 lot subdivision,” said Chadwick.

Chadwick said the road is about 1,000 feet long and ends with a

cul-de-sac where the 13 proposed homes would be built. He said that they have already obtained all of the state permits that they will need, including a wetland permit.

One of the items discussed throughout the process was whether or not they’d be able to keep the house that is still in place on the property.

Chadwick stated that they haven’t gone through the house thoroughly yet, but their hope is to be able to keep it.

“It does give a good backdrop to the project,” said Chadwick.

In addition, he said they are hoping to be able to keep the barn on the property as well.

There was only one abutter that had concerns with the new development. A King Charles Drive resident wrote a letter to the board, which was read into the minutes. They stated that they were concerned about the current level of privacy they have now and are concerned they would

be losing it with the new development.

Planning Board Chair, Art Rugg, asked if there was anything that could be done to keep some of the natural vegetation in place.

Chadwick said that because of the way the plans are designed, he doesn’t know if there is much more natural vegetation that they can offer them.

One of the conditions discussed by the Planning Board was to have the speed limit posted for under 35 miles per hour as a way to address speeding if it’s approved by the Town Council, which the applicant was

in full support of.

Overall, the board saw nothing wrong with the plan as it was proposed.

“Everything looks great,” said Town Council Ex-Officio, Ted Combes.

Ex-Officio, Bruce Hallowell, said he was happy about the sidewalk that would be added as part of the development.

“I’m excited about a sidewalk,” Hallowell said.

The Planning Board approved the subdivision plan.

The next Planning Board meeting is slated to take place on May 3 at 7 p.m.

The Town Charter requires adoption of Council rules of order to occur at the reorganizational meeting within 10 days of the Town Election, but a review of minutes, or a simple watch of the Youtube video proceedings, will show that this did not occur. This is particularly important to note, as rules of order for the Council typically include how the Council facilitates public comment.

At the March 27 Reorganizational Meeting, Town Council Chairman John Farrell did give “recommended suggestions” regarding the facilitation of public comment, to include sticking to items on the agenda and not naming Town Officials by name. However, it must be stated that no such motion or vote occurred as required by the Charter, to officially adopt these rules for public com-

ment, which were a reiteration of rules adopted by the council in 2018. Chairman Farrell has been clear several times that prior sessions of the Town Council cannot encumber the current session. Not only that, but the 2018 rules that he attempted to reiterate were largely “idealistic but unenforceable” as noted when they passed by then-Chairman Tom Dolan. This is not new to our Council! 3 out of 5 current members of the Town Council received a briefing in 2017, from Stephen Buckley Esq. of the New Hampshire Municipal Association, very narrowly defining how public comment may be limited. Our Town Council has known for years that aside from setting the place of public comment, limiting the time of each speaker, and prohibiting fighting words or other unprotected speech under the First Amendment, that

they largely cannot limit public comment. Between the above-noted limitations and the fact that no vote was held at the reorganizational meeting, our Town has no business placing restrictions on citizens’ speech.

It is a sad day, when asking for accountability and pointing out errors in official procedure leads to Councilman Jim Butler calling a citizen a joke. I would call it hiding, when Chairman Farrell speaks only after closing public comment and gaveling down citizens so he can attempt to have the last word without rebuttal. And it is inappropriate when the chairman’s wife (our Town Clerk) is clapping for him in the audience...which is against the very non-existent rules we are discussing. Is Public Comment a joke to you? Because it is to our town officials.

# Planning Board Approve Tree Cutting Along Adams Road

The Planning Board heard a number of applications during its April 5 meeting, including a request by Eversource for the removal and trimming of trees along Adams Road, which is designated as a scenic road.

Representing Eversource was Alison Marcotte, a utility arborist

with Eversource, who said they were looking to do maintenance trimming on the road.

"We are doing our maintenance trimming on Adams Road," said Marcotte.

She said some of the trees they were looking for approval for were dead trees.

"There are about six dead and two declining trees along Adams road

that we're seeking to be removed," said Marcotte, noting that they are along the scenic road.

Marcotte said that it's something they do every four to five years and all the abutters and property owners have been notified.

She told the board they would also be removing the wood unless there is a request to

keep it there.

"With removals, we will remove wood unless the homeowner requests we leave the wood," said Marcotte.

Marcotte said there is a fair amount of trees at 1 Adams Road, which will be addressed.

"It's a bunch of pines that are all dead. So those are the ones we're looking to remove," said Marcotte.

For 14 Adams Road, there is a large 30 inch pine "that has a large rot on the back and that one's across the road."

She stated there are three others at 14 Adams Road "that also have rot either at the primary or are starting to uproot."

At 56 Adams Road, Marcotte said "there are some maples that are leaning and uprooted and rot in the trunk."

For 73 Adams Road, there are two dead elm trees and at 90 Adams Road, there are two maples, one which has a rot in the trunk and the other that is close to the primary wire.

Planning Board member, Ann Chiampa, said she agreed with all of the maples that will be addressed.

"I went and looked back and forth," Chiampa said.

Planning Board Chair, Art Rugg, said they can have a condition that the board could look at the specific locations by

the end of the week and if they had any questions they could let Assistant Town Manager, Kellie Caron, know.

Chiampa stated that they would be able to begin the cutting of the trees as soon as they got approval from the board.

The Planning Board unanimously approved allowing for the removal of the trees.

Following the vote, Rugg noted that the road isn't as scenic as it once was.

"It's not the scenic road it used to be, but times change," Rugg said.

The next Planning Board meeting is slated to take place on May 3 at 7 p.m.

research, found they were actually adopted in 2018 and haven't been readopted since then.

He then cited that the Charter requires the board to adopt the rules of the Council each year within ten days of the election. He added that since the rules have not been voted on and felt they cannot be considered valid.

Douglas also took exception to a "Letter to the Editor" written by the Town Manager, Mike Malaguti. The part of the letter Douglas was most concerned about read, "The loudest voices at this moment seek chaos as an end in itself, and are employing conspiracy theories, name calling, and misinformation to drown out everyone else," and "We need the reasonable middle to fill more of the room, literally and figuratively...because if you don't, Londonderry's most divisive voices surely will."

Douglas said that when he read the letter, "I almost fell off my

chair."

He admitted that he must be considered one of these "divisive voices," but most of the information he has been discussing has been received through 91A requests and there has been no "name calling."

Resident, Jonathan Esposito, also echoed Douglas' sentiments, saying there has never been a vote on the rules of order by the newly elected board and felt the new rules posted on the town website are not valid until they are voted on.

Councilor, Jim Butler, rebutted some of the comments made after public comment was closed by Chairman, John Farrell.

He suggested that the video made of the meetings should be entered into the record as part of the minutes of the meeting. He added, "So when someone accuses us of not doing something, everyone can see on the video what's going on and we correct some of these problems."

Butler also suggested

that those who have problems with the way things are being run to come back with solutions. "Because I'm tired of listening to a small group of people."

Throughout Butlers comments, the people whom the comments were directed at tried to respond from the audience, but each time they did, they were gavelled down by the Chairman until Esposito left.

Just before the meeting adjourned, Farrell addressed the issues that have been frequently coming up about council procedures.

Farrell said, "It's very apparent I have my haters and my naysayers and they have a lot to say about it. They believe we're corrupt, they believe we're stealing, and there's a conflict of interest. They believe all these things are happening." He added, "Folks, this isn't an easy job. People give their time. This is a volunteer position and we're trying to do our best job within the limits we have. We always try to do the right thing."

# April Celebrates Canine Health Awareness Month

The month of April is considered Canine Fitness Month, a time dedicated to focusing on keeping man's best friend healthy and active.

According to the most recent data available from the North American Veterinary Community (NAVC), in association with the Banfield Pet Hospital Network, a Veterinary Emerging Topics (VET) Report revealed that more than half of all adult dogs seen at over 1,000 Banfield hospitals alone were considered overweight or obese in 2019.

The report also showed that less than 10% of these pets successfully went on to lose weight following their diagnoses, and of those, roughly 40% ended up

gaining weight back within a year.

Excess weight in pets is associated with a number of adverse health conditions, says the American Animal Hospital Association (AAHA). These conditions include Endocrinopathies, metabolic abnormalities, cardiovascular disease, decreased immune functions, joint problems, and more.

Just like humans, there are a number of different factors that can lead to canine obesity, according to Doctor of Veterinary Medicine, Christopher G. Byers.

Perhaps the biggest factor in weight gain is the ratio of exercise or activity to the amount of food a dog eats. The amount of food per meal, number of snacks and treats, and food quality can adversely

affect a dog's weight.

"Indiscriminate feeding habits including feeding table scraps, poor diet, and constant access to food are significant contributing factors to this most prevalent issue in canine population." Dr. Byers wrote in his conclusion to the article: "Obesity in dogs... exploring the causes and consequences of canine obesity."

As it turns out, there are several dog breeds that have a biological predisposition to obesity, wrote Dr. Byers. These breeds include Cairn Terriers, West Highland White Terriers, Scottish Terriers, Shetland Sheepdogs, Basset Hounds, Cavalier King Charles Spaniels, Dachshunds, Beagles, Cocker Spaniels, and Labrador Retrievers.

Interestingly, Dr. Byers noted that certain dog breeds, particularly sight hounds (dogs such as Greyhounds, Whippets, etc), appear to be resistant to the development of obesity. This is due largely in part to their aerodynamic body structure and unique metabolisms which allow these breeds to move at great bursts of speed to chase down fast-footed game, says the American Kennel Club.

Age is also a factor in animal weight gain, continued Dr. Byers, as lean body mass declines as dogs get older. This loss is often exacerbated if voluntary activity is also decreased along with age. Furthermore, if food intake does not decrease proportionately with decreasing energy needs, this results in Fluffy gaining weight.

Dogs can also gain weight after being spayed or neutered. Changes in these hormones directly affect the satiety (feeling of fullness) center of the brain, causing spayed and neutered dogs to eat more food than is required for their energy levels, resulting in weight gain.

There are also certain medications that contribute to animal weight gain, including Phenobarbital and Glucocorticoids, particularly if taken over a long period of time.

Owners who suspect their furry family member may need to shed a few pounds, the first step shouldn't be diving head-first into a new diet and exercise regimen. At least not without consulting a doctor first.

Blue Cross for Pets says, "It is best to start

with a trip to the vet... your pet will need a check-up for medical conditions that could interfere (with weight loss)."

From there, the Vet can help begin a weight-loss journey best suited for the dog's unique needs. Most practices also offer calorie-controlled foods and weight control clinics to aid in getting pets back to their optimal health.

Of course, prevention is the best way to control a dog's weight. Ensuring pets get plenty of exercise and activity, eat the right foods in the right amounts, and getting annual wellness screenings can help keep dogs at their healthy weight. The Veterinarian can also help advise the owner what food and how much of it is best for his or her canine friend.
