Resident Denied Variance to Manufacture Beer in AR-1

The Zoning Board of Adjustment heard a case regarding a variance request to allow manufacturing in the AR-1 Zone during the Feb. 15 meeting.

It was explained by Michaela Waldron, the owner of 83 Litchfield

Road, that she was looking to be able to convert the garage into a place to manufacture beer.

"We're looking to manufacture on a small scale," said Waldron.

Waldron said it wouldn't be open to the public, which means there wouldn't be any additional traffic. She

also noted they wouldn't have any employees, and the only two people doing the work would be herself and the applicant, John Thompson.

"We won't be hiring anyone else to do this," said Waldron.

She said it will allow them to use their prop-

Article to Appoint Treasurer Brings Debate at Deliberative

The town budget wasn't the only thing up for debate at the recent Deliberative Session. A controversial proposal was Article 2, which would amend the town charter to make the position of Treasurer appointed by the Town Council instead of being directly elected. The idea of turning an elected position into an appointed one drew controversy.

"I can appreciate wanting an independent party for this," said town resident, Daniel Bouchard.

"My concern is that if the Town Manager doesn't like what the Town Treasurer is doing, is that treasurer going to be escorted out of the Town Hall, and not allowed to do their job? Right now, the Town Treasurer is elected and you can't do that."

Town Manager, Michael Malaguti, assured Bouchard that such a scenario was impossible and that an appointed Treasurer had a fixed term. "The Town Treasurer is controlled by state law." He further elaborated on the duties of the Treasurer, who

oversees Londonderry expenses while seeing that the town gets the best bank interest rates. "They're in charge of the financial aspect of the town is the long and short of it."

Councilors originally proposed the change due to concerns over the office of the Treasurer and a fear that money could be stolen or mismanaged by an elected, unqualified Treasurer. Currently, the only requirement is that a resident of Londonderry 18 or older wins the election without the

Superintendent Gives Snapshot of District During Deliberative

Before the Londonderry School District Deliberative Session began on Feb. 11, Superintendent, Dan Black, gave the public an update of what is happening with the school district.

"We're back to normal and we're loving it," said Black.

He explained that for a couple of years during the height of the Covid-19 pandemic "there were some dark days."

However, around this time last year, things began to turn around, he said.

"That's where we are right now," said Black.

In addition to academics, Black said overall, the school district wants students to be career and college ready as well as well rounded students.

"We want to make sure they have a great co-curricular program to learn outside the classroom as well," said Black.

One of the things pointed out by Black is their quest to continue to improve their academic program. He added that most years they have around 85 to 90 percent of their students that are accepted into a two or four year college before graduation, and nearly 700 stu-

dents are enrolled in AP classes and or running start classes at the high school.

Black also noted that students are "consistently above state and national averages on i-Ready, PSAT, SAT, and NH Standardized tests,"

"It's a very strong place to be," said Black.

Black said that one of the focuses in order to

Planning Board Recommend Rezoning of YMCA Property

The Planning Board heard a rezoning request recently that would allow the YMCA to rezone their property located at 206 Rockingham Road, from C-I (Commercial I), C-II (Commercial II), and AR-I (Agricultural-Residential I) to C-II (Commercial II).

Representing the YMCA plan was Steve Keach. He explained that the YMCA previously obtained the different parcels and in 2017, the former Town Planner recommended they voluntarily merge the lots into one 15.1 acre parcel.

"As the result of the

parcel being comprised of multiple smaller parcels the current zoning overlaying the property is fragmented," Keach wrote in a narrative to the Planning Board. "The property includes Agricultural-Residential (AR-I), Commercial I (C-I), Commercial II (C-II) and Route 28 Performance Overlay Zoning Districts."

In late 2019, Keach stated they prepared an application that wasn't submitted due to the Covid-19 pandemic.

"Basically this is a housekeeping matter," said Keach.

Keach explained they have no immediate plans for development, but

said it is likely they will continue their pattern of growth and may need to continue to expand in the future.

"This rezoning will not modify the existing use, therefore there will be no impact to the health, safety, and general welfare of the community," said Keach.

Community member, Ray Breslin, said he questioned what the purpose of the request was.

"I really would have to wonder the purpose of changing it. What is the purpose," he said.

Ex-Officio, Deb Paul, noted that from time to time it is noticed that zoning needs to be fixed like in this situation.

"It really is just housekeeping," said Paul.

Breslin also pointed out there are a lot of things happening on Rockingham Road.

"We have some real important issues we have to deal with," said Breslin.

Keach said by having everything zoned the same it would make it easier for future developments.

One concern that was raised by Planning Board member, Anne Chiampa, was the fact that a lot of it borders up to the AR-I District.

"A good portion of this development has residential borders," she said.

Keach explained that it would be difficult for anything to go there other than the YMCA saying a lot of the land was donated with a specific purpose and if they weren't to have the YMCA there anymore they would have to give the land back.

One of the abutters that spoke during the meeting was Michael Eaton.

"I'm across the street from this," said Eaton.

He asked if the buffer would change.

Assistant Town Manager, Kellie Caron, said it would remain 50 feet.

She said some of the differences between C-II and C-I is what is

allowed.

For example, she said drive in movie theaters and recreational facilities are allowed in C-II and not C-I

"Its slightly more intense uses," said Caron.

Planning Board member, Lynn Wiles, said he didn't see why they needed to change it right away.

"I just don't see a reason to do it tonight," said Wiles.

The Planning Board voted 6-2-1 in support of recommending that the Town Council change the zoning with Wiles and Chiampa voting against it and Paul abstaining.

Young Road Homes Move Forward, Catmint Removed from Plan

The Conservation Commission met recently and discussed the design of the ongoing Winnie Estates plan.

Jeff Brem from the Meisner Brem Corporation was at the meeting to represent Winnie Estates. The Commission previously asked Brem to work towards a design that would connect the wetlands near Young Road separated by a driveway under the old proposal.

"We'll take out this driveway and reconnect the wetland," Brem offered, "But we'd like to

do some of this work first, and when it's established and finished, we'll come back and remove the roadway." Winnie Estates would do the initial landscaping work and fulfill the wetland request later.

No members objected to the wetland idea, although Commissioner, Deborah Lievens, questioned the inclusion of catmint in the landscaping plan.

"As a plant lover and a cat lover, I do see the catmint, and I was wondering if there was maybe something else you could put in just to stave off problems if anyone has cats," asked

Lievens. "Cats love it, I wonder if you could remove it for simplicity's sake."

While there were a few comments about the inclusion of non-native plants, the Conservation Commission seemed to agree with the revised proposal. Formal hearings for the project could happen in April, though there is no solid date.

Members also oversaw the resubmission of a wetlands permit from a proposal on the Moose Hill Estates project on Sargent Road.

George Chadwick of the Manchester Bedford Design Consultants was

at the meeting to make the formal request. Chadwick initially hoped to move forward with the project after a similar request two months ago. The first permit was blocked by the state on a technicality.

"The impacts haven't changed, nothing changed as a result of the application other than the form I filled out," said a slightly frustrated Chadwick. "I just wanted to give you an update on why there's another wet-

land application here, nothing changed."

With no changes, the Commission has nothing to say. Chadwick plans to hold a full hearing for the Moose Hill Plan in March or April.

Debate from the last meeting over what to do with a wetland causeway has slowed the approval of grant money for the preservation project at Lithia Springs.

"This sets up back and would require us to do an extension," said Commission Chair, Marge Badois. "We're looking at whether there's enough money on the conservation account to close the project to get reimbursed." She wanted to

avoid extending the project beyond spring.

Lievens believed it would be possible to move forward, even with the grant delay.

The University of NH Cooperative Extension is presenting the annual Saving Special Places land conservation event on Saturday, April 15. "The event is always worthwhile I think," said Badois.

There will also be Saving Special Places Zoom presentations on Friday, March 3 and Sunday, April 2.

The next meeting of the Conservation Commission is scheduled for Tuesday, Feb. 28 at 7:30 pm in the Moose Hill Council Chambers.

Town Council Discuss Possibility of Pickleball Courts

One of the topics discussed during the Feb. 6 Town Council meeting was in regards to pickleball potentially coming to town.

Heather Burr Carey spoke during public comment holding a pickleball, saying it's the fastest growing sport in the nation.

She said Londonderry is behind when it comes to bringing it to town.

"There are lots of communities and even school districts imple-

menting it across the state, the country," said Burr Carey.

She noted last year a warrant article was put on the ballot to start looking at engineering to build eight new courts off of West Road.

"The overall cost would've been about \$250,000, so that was just the first step," said Burr Carey.

She noted that the article lost by 169 votes, which was a "minimal number."

"I will take a lot of credit for that because I feel like we needed more

information out there and everyone needed to understand more about the sport, about the people that want to play it, and the necessity for it in town," said Burr Carey.

Burr Carey said she was looking for guidance on how they can move forward.

"I'm coming to you tonight because I have heard even more chatter about pickleball, so I wanted to share a little bit," said Burr Carey.

She stated she spoke last year to the Senior Resources Committee

about how there are AARP grants available.

"There are grants available," Burr Carey said.

This year she said there is a grant from the NH Division of Parks and Recreation.

"We would possibly qualify for it," said Burr Carey, explaining that there is a process that would start this year.

Burr Carey said that there has been some discussion about painting tennis courts in

town.

"That would probably be about \$6,000 to paint two of our four tennis courts. That would give us eight pickleball courts," said Burr Carey.

Burr Carey said they are hesitant to go that route because it would take away from building eight full courts and would limit how much time is available for the tennis players.

"We don't want to take away from one

sport to bring in another sport," said Burr Carey.

Town Council Chair, John Farrell, asked that it be put on the agenda for the next meeting so they can see what would need to be done to bring it to town.

"Let's dive into it," said Farrell.

Town Councilor, Deb Paul, suggested having the Senior Affairs Director and the Recreation Director attend the meeting.

need to vet qualified candidates. Appointed Treasurers would need to submit a resume before consideration, something not currently needed.

Despite the explanation, some believed that an appointed Treasurer would be just as likely to cause trouble under the wrong circumstances.

"I understand your worry about having someone elected who is not qualified," said Maria Barud. "My worry is that if this is an appointed position, this gives the Town Council the opportunity to rubber stamping and we've seen a lot of that lately." She urged people to vote no on the article.

Others worried about the apparent speed of the proposal, asking the Town Hall to examine other options at least or

delay Article 2 to the November election.

"With removing power from the hands of voters and putting it in the hands of other people, I suggest that we take the time to examine other options," said Shawn Faber. "I just think this is being rushed through, and I would like to take some time and really think about this."

Opposition wasn't just from the public, there was a debate within the Town Council over the best course of action.

"I voted no on this," said Councilor, Deb Paul. "I don't see the reason for this, we're losing our rights."

Her concern was whether Londonderry's money would be any more secure with an appointed Treasurer.

Councilor, Joe Green, disagreed. "The reason I voted yes on this is that I want to give the decision back to the voters.

The people of Londonderry will make the decision over whether to make the position appointed or elected."

Bouchard finished the discussion by opposing Green's comment, saying that the voters have already spoken on this years ago, when they voted on the Town Charter. "My opinion is, the town already decided on this."

Article 2 moved to the warrant for a final, public vote along with the budget and other proposed changes on Tuesday, March 14.

improve academics is through "portrait of a graduate."

"This vision of our academic program is being embedded in all our curriculum work as a district," Black said.

Another thing that was pointed out by Black is the goal of having a positive school culture.

"We always want to make sure we have a positive school culture in our classrooms, and that's a very hard thing to do," said Black.

He stated that this year rebuilding a posi-

tive school culture has gone well.

Where the school district is focusing their efforts on has also shifted, Black pointed out.

"After many years of implementing Math in Focus grades K to 8 as a system, our elementary schools are now shifting their focus on literacy to make sure we build more skilled readers, writers, and communicators for their 6 to 12 classes," said Black.

Additionally, Black also pointed to a shift of their curriculum to meet the digital age.

For example, he said that starting in the fall, after three years of

budgets, Londonderry High School students will all have their own devices making the school 1 to 1. He added that if the warrant article is approved then it would mean that Londonderry Middle School will be in the same situation. They have also included a mobile technician in the budget to help support the additional devices added to the district over the last few years.

Black said they want to continue to improve, and that the staff is focused on it.

"We always want to get better," said Black.

What is going on in Londonderry?

To the editor,

If you were a lucky Londonderry citizen during the month of November 2022, you would have been able to apply for use of LPD's community conference room. This room historically has hosted everything from pumpkin carvings to meet and greet of candidates for public offices. This used to be

through a less formal process, but the Chief began taking applications in November.

In early December 2022, I was told by Chief Bernard that the application form to apply for Community Room use was not on LPD's website, but LPD would email it to you "upon request."

I wrote to Chief Bernard and asked for this form on Jan. 9, 2023, only a handful of weeks later. Chief replied that he had decided "weeks ago" (so early Dec.?) that civilian use of the Community room was disallowed.

I inquired with the town manager Michael Malaguti on Jan. 12, as he originally had advised citizens RE this process.

I received a copy of a policy dated 1.19.23 (10 days AFTER my inquiry for use) stating that the community room is no longer open for citizen use.

That is awfully convenient timing.

If you inquire with the town managers office, about Town Hall, you will not get a much better response.

These often unused meeting rooms that WE pay for cost roughly the same (electric, water, lighting, cleaning) as they would if citizens were using them infrequently. So why can't we?

A review of Town Hall Meeting Room schedules shows that select nonprofits with Town Council ties have routinely secured use of these meeting rooms for years. It is only now that Michael Malaguti is telling select citizens "no."

Mike can cite the Town Charter as giving him unilateral authority regarding use of town facilities. He isn't so ready to answer why his authority is

applied arbitrarily.

Londonderry citizens have almost always enjoyed some, if limited, access to use of town facilities in normal, orderly fashions that did not otherwise disrupt municipal business.

It is very concerning that there is a sudden policy and preference change from the town

Why? Certainly, it can't be a safety issue for the town. Our Town facilities are staffed by fine professionals and watched over by LPD.

No one is suggesting turning Town Hall into a party rental business.

However, as the town manager continues to aggressively "reorganize" Town Hall, surely the assistant town manager, could be the POC for the occasional citizen request.

It seems as if there is an unfavorable wind blowing through Town Hall at this time.

If you cannot attend a Town Council Meeting, it's easy enough to pop on YouTube and stream it live while you're engaged in your evening business. Better yet, write to them at towncouncil@londonderry.org and ask for a documented response – What is going on in Londonderry?

Lancer Wrestlers Take Third in State & Two Top Spots

The Londonderry High School Wrestling team hosted the New Hampshire Inter-scholastic Athletic Association's Division I Championship on Saturday, Feb. 18, and had some exceptional finishes in a number of weight classes.

Lancer sophomore David Pento Jr. remained

undefeated in the state of NH in the 152-pound division this year after collecting three wins and the Division I title.

Londonderry junior Patrick O'Connor also took home a DI title with four match victories, including a very nice win in the championship round over David Jacques of Salem High School.

As a team, Londonderry

scored 161.5 points for a third-place in the Championship. The Blue Devils bested the Timberlane Owls with 256-points over 173-points for the top spot, a feat that hasn't been achieved since Londonderry did it back in 2015. The Plaistow powerhouse has achieved 23 State Titles since 2000.

Pento began his day in the quarterfinal round,

after receiving a bye as the top-seeded wrestler. In his first match, Pento pinned Pinkerton Academy's Cameran Morrow in 1:28 of the match. Moving onto the Semifinals, Pento had another fall win, this time against William Hartford of Exeter at 4:26 in the match.

Pento's title-winning victory came at the expense of Timberlane's

Ben Little, who put up an excellent effort in the championship round, but was outscored 9-5.

In the 170-pound division, O'Connor had wins in four matches as the second seed, and beat the top-seed in the championship match.

O'Connor's day started with a first-round, 9-0 win over Owen Hope of Keene. From there, he

pinned Robert Craig of Bedford in the Quarters, then got a 5-3 win over Constantine Isaac of Windham in the Semifinals. In the finals, O'Connor shocked the number-one seed at 5:06 in the match with a reversal that evolved into a pin for the title.

Londonderry's 132-lbs. senior, Nicolas D'A-

Londonderry Boys' Basketball Split in Two Home Games

The Londonderry High School Boys' Basketball squad was hoping to finish the season with four wins and give themselves an outside chance of getting into the Division I playoffs, but a double overtime loss to Windham to begin the week spoiled that hope.

On Tuesday night, Feb. 14, the Lancers welcomed the Windham High School Jaguars into their home gym and battled through six periods before finally falling three points short in the second overtime period.

Londonderry started the game with three, three-pointers and a lay-up to trail the Jags 12-11 by the end of the first quarter.

In quarter number two, LHS had a 19-11 scoring advantage over

WHS and looked to be in pretty good shape headed into the locker room at the half 30-23.

The break killed any momentum the Lancers gained in the second period, scoring just seven points to Windham's 13 for a 37-36 lead.

In the fourth, both side struggled at the basket, but Windham went ahead with five minutes left in regulation and held the lead until just over a minute to play when senior Trevor Edmonds got a two-point bucket from the paint for the 43-43 tie.

Currier was able to tally one-point after being fouled.

Rourke had 19-points in the game including four, three-pointers. Paquette also had four three-pointers and scored 16-points total. Edmonds and Rondeau each finished with 11-points.

They will face the winless Manchester Central squad in the Queen City on Tuesday night, Feb. 21 where they hope to get their ninth win.

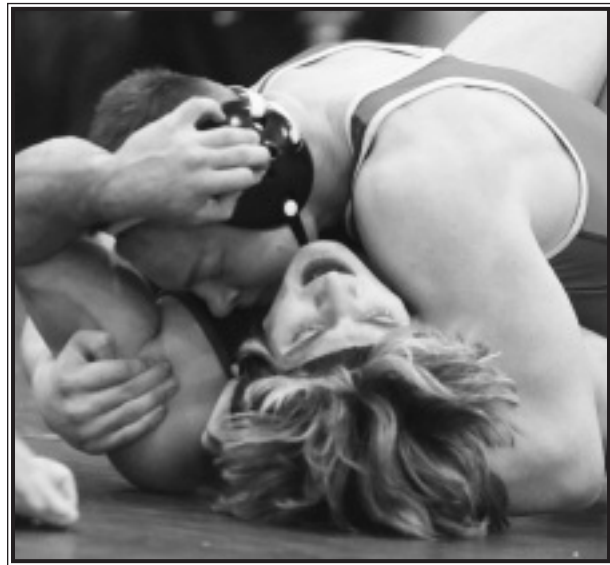
On Friday night, at home, the Lancers will host Manchester Memorial (9-8) starting at 7 p.m.

allow them to use their property for a business.

"This would allow us to create local business and revenue," said Waldron.

Waldron said there wouldn't be any changes made to the outside structure of the garage other than removing the garage door and putting

in french doors.

"Other than that there will be no change," said Waldron.

One question that was asked was in regards to what chemicals would be used.

Waldron stated that other than natural foods, like grains and water they would be using food grade sanitizer.

In terms of odors, Waldron said they have been brewing just for family and friends week-

ly and haven't had any issues.

"There have been no smells around the house," said Waldron.

Waldron explained that in order to get a nano brewery license they need to have a space that is separate from the house.

"Without a space like that we won't be able to get a license," said Waldron.

Waldron explained that they plan to sell

locally at farmers markets and possibly during the winter at local stores.

"That's our vision," said Waldron.

One of the abutters that spoke during the meeting was Allan Saulnier who said he was concerned that the variance could cause a precedent.

"You're putting a very specific variance in a residential area," said Saulnier.

Town Council Liaison, Deb Paul, asked if the well was tested for PFAS, and also asked if the fire department looked at it, noting that the tanks used can be dangerous.

Waldron said they are in the process of having it tested. She added that right now they already get water delivered and if there are still issues with the water they will continue to do so.

Assistant Town Manager, Kellie Caron, said

the fire department would become involved during the building permit process.

"That would be addressed," said Caron.

Paul also asked if it's going to be the same size garage and asked about the dimensions.

Waldron said that they wouldn't be expanding the garage at all and all the equipment would be in the garage.

The variance request was ultimately denied.
